Eligibility. To be considered, the project representative must be a current ASHE member. Applications may be submitted by a hospital or hospital system employee, or by a consultant and/or other service provider, but a current ASHE member must be listed as the project representative.

Selection. Selections are based on project results and effect on patient care, not on size or cost. Nominations are evaluated by a select committee within ASHE volunteer leadership. ASHE's executive steering committee or board of directors provides final approval of the committee's selected winner.

The award recipient will be notified no later than October 2, 2020. ASHE will announce the winner during National Health Care Facilities & Engineering Week, October 18-24, 2020.

Obligations. The winning individual and/or team will be expected to participate in a variety of efforts that educate the field about your innovative project. This may include volunteering on an ASHE committee, participating in the award presentation and education session at the ASHE Annual Conference in 2021, and assisting writers in developing a feature article to appear in ASHE's *Health Facilities Management Magazine*, or other industry-related publications.*
