



Crystal Eagle Award

The Crystal Eagle Leadership Award recognizes one outstanding member each year for their generous and long-standing service to ASHE and their contributions to advance the field of health care engineering and facilities management.

To nominate a fellow ASHE member for this award, you must be a current member in good standing with ASHE.

Application will open on February 1 and close on April 1 with notification happening in early May.

Award recipients receive

- Custom Engraved Award recognizing excellence and achievement
- Full Conference Registration to HFIC, providing access to premier education, networking, and industry insights
- Lifetime ASHE membership, extending engagement and professional growth opportunities
- Hotel Accommodations during HFIC, ensuring recipients can fully participate in conference programming
- Round trip airfare from recipients home airport to HFIC
- National Recognition via the ASHE Website and Official Press Release

Selection process

- Nominations will be evaluated by the ASHE Awards and Recognition Committee.
- Decisions made by the Committee are final pending approval by the ASHE Executive Committee

Criteria

- The preparer of the application, nominator, must be an ASHE member in good standing at the time of application. Membership ID must be provided.
- Candidate must be a current ASHE member in good standing for 10 (ten) years or more at the time of application. Membership ID must be provided.
- Candidate must be a current member in good standing with an ASHE affiliate chapter with two (2) years or more of consecutive membership at the time of application. Confirmation letter on Chapter letterhead must be submitted.

- Candidate must meet the following requirements, at the time of application:
 - Hold the designation of either:
 - Fellow (FASHE)
 - Senior (SASHE)

AND

- Meet one (1) of the following criteria listed below:
 - Certified Healthcare Facility Manager (CHFM)
 - Certified Healthcare Constructor (CHC)
 - Past member of the ASHE Board of Directors
 - Past ASHE committee/taskforce chairman
- Applications must include three (3) letters of recommendation. Letters can be submitted by the following:
 - Nominees' manager/supervisor, hospital CEO, department VP or administrator.
 - Current ASHE Chapter President
 - Current ASHE member
 - Professional colleague (non-ASHE member)
 - Current ASHE Advisory Board members are not eligible to submit letters of recommendation.
- As the preparer of this application, you are required to submit a written narrative (or nomination letter) your written narrative must be dated and include your signature. The narrative must be a minimum of 500 words and address all of the following:
 - Reasons for nominating the individual
 - Key examples of their contributions to ASHE and its mission
 - How the candidate exemplifies the spirit of the award
- Professional resume or public LinkedIn profile must be provided
- Professional color photo must be provided.
