Third-Party Reporting

Description

Organizations taking a leading role in sustainability often join or participate in third-party programs. These initiatives increase the transparency of an organization's progress toward sustainability goals, involve a commitment from senior leadership and provide an opportunity to highlight successful organization operations. From a pay-forward perspective, the goal of participating in these initiatives is to facilitate faster adoption across many sectors.

Project Talking Points

- Selecting the right third-party reporting program(s) for your organization.
- Setting baselines, long-term goals and strategies to achieve outcomes associated with selected third-party programs.
- Developing resources that guide individuals to be conscious of behaviors that impact the organization's long-term goals.

Benefits

- **Cost benefits:** Third-party reporting will not directly reduce operating costs. However, the impact on operational efficiency will indirectly reduce costs. Also, operations credentialed by unbiased third parties can have a greater impact on attracting staff and patients than self-promoted operations.
- **Environmental benefits:** Although the environmental benefits are realized prior to third-party reporting, result validation and audits provide value to both health care staff and the communities they serve.
- **Social benefits:** Public reporting and third-party validation of sustainability practices have significant social benefit. More than other sectors, health care organizations hold a position of trust with the public and are viewed as essential members of communities. Participating in third-party reporting programs will allow for greater public awareness of sustainability issues and greater adoption of sustainability best practices across several sectors.

Purchasing Considerations

Implementing a third-party reporting program can have subscription, membership or filing fees associated with periodic (typically annual) reporting.

- Evaluate the right third-party reporting program for your region and your organization's sustainability initiatives to maximize impact.

How-To

1. Research local and regional third-party reporting programs in your operational footprint. Local and regional programs typically involve water management, recycling or community solar initiatives.
2. Determine which department or team will handle the third-party reporting requirements. Appropriate departments are generally environmental services, purchasing or facility management. In some cases, reporting may be facilitated by marketing or finance departments.
3. Gain leadership commitment to the third-party reporting program.
4. Enroll in the third-party reporting program.
5. Develop goals that are specific, measurable, achievable, realistic and timely.
6. Track your progress against a baseline to report on the required interval.
7. Celebrate your organization's success and share results with staff and the public.
